**INTEREST RATE CONDITIONS OF THE MAGYAR NEMZETI BANK
EFFECTIVE FROM 30 NOVEMBER 2010**

The Monetary Council of the Magyar Nemzeti Bank increased the central bank base rate by 25 basis points to 5.5%, in effect from 30 November 2010.

Based on the Monetary Council's decision, the new interest rate conditions of the Magyar Nemzeti Bank, in effect from 30 November 2010, are as follows:

Central bank instrument	Interest rate	
Two-week MNB bill		5.5%
Overnight central bank deposit	The interest rate on the two-week MNB bill minus 1.0 percentage point	4.5%
Overnight collateralised loan	The interest rate on the two-week MNB bill plus 1.0 percentage point	6.5%

Central bank base rate is 5.5%.

The interest rate remunerated on required reserves is 5.5%.

The penalty interest rate applied in case of reserve deficit is 5.5%.
