

Data protection information

Personal data recorded by the Magyar Nemzeti Bank (hereinafter: the MNB) at the registration of participants at MNB Summer School of Economics 2018 ("Event") will be managed by the MNB in line with the effective, relevant data protection legislation as follows.

Data controller:

Magyar Nemzeti Bank

Scope of managed data:

Data provided by participants upon registration: name, email address, nationality, sex, date of birth, passport number, address, mobile number, emergency contact person, phone number emergency contact person, home university, field of study, year, (Expected) date of graduation, overall GPA, language skills, CV

Legal basis of data management:

With the knowledge of this information release a clear consent by the person participating in the registration process. A statement thereof should be indicated by ticking the checkbox upon registration.

Aim and time of data management:

The MNB manages the data to identify participants. Only the colleagues, who are part of the team responsible for the organisation of the Event, have access to them. During data management the MNB will not employ a data processing agent. The controller handles data until possible claims resulting from legal relationship can be enforced or for up to two years.

Forwarding data:

The MNB may forward the data to a third party on the basis of the relevant legislation concerning the fight against terrorism and in line with the regulations of Act CXXV of 1995 on the National Security Services.

Rights of the affected parties:

The affected person may request to be informed with regards to the management of their personal data; or they may request their personal data to be corrected, deleted or blocked.

In case of a petition regarding this, the MNB will provide information on the data belonging to the affected person managed and processed by the Bank or processed by a data processing agent as per the Bank's instructions, the source thereof, the aim of the data management, the legal grounds thereof, its duration, the name and address of the data processing agent, and its activity in relation to data management; and in case of data transfer, information will be provided on the legal grounds of the data transfer and its addressee in the shortest possible time, but within a maximum of 25 days.

Legal remedy:

If, in the affected person's judgement, data management does not comply with the legal requirements, they have the option to initiate the proceedings of the MNB's internal data protection officer, or they can bring the matter before court. Court proceedings may only be initiated against the MNB in its registered seat in Hungary.

In addition, an investigation may be initiated by filing a report to the National Authority for Data Protection and Freedom of Information on the grounds that there was an infringement in practising the rights related to personal data management or there is imminent danger thereof.
