Preliminary statistical balance sheet of the NBH April 2002

According to the preliminary balance sheet data, the value of banknotes and coin in circulation was Ft 6.2 billion higher at the end of April than at end-March. The annual growth index of the monetary base (M0)^{a)} was 116.1%.

The fall in net claims of the central bank on the central government amounted to Ft 14.4 billion. Assets and liabilities vis-à-vis the central government fell by Ft 14.8 billion and Ft 0.4 billion respectively relative to March. Net foreign assets of the central bank were Ft 23.7 billion lower in a one-month comparison. Foreign assets of the central bank fell by Ft 6.3 billion, liabilities rising by Ft 17.4 billion.

Net liabilities of the central bank to other monetary financial institutions fell by Ft 2.8 billion. Other monetary financial institutions placed Ft 15.8 billion less domestic and foreign currency deposits with the central bank in April than in March. Their total liabilities to the central bank fell by Ft 13 billion. From among liabilities to other monetary financial institutions, current account balances, which comprise required reserve holdings, experienced the largest change, falling by Ft 76.1 billion in one month. Closely related to this change, forint deposits increased by Ft 67.6 billion. The value of other monetary financial institutions' holdings of NBH domestic bills was Ft 8 billion lower relative to March.

In April, the averages of central bank liabilities to other monetary financial institutions changed as follows: the averages of reserve balances at the central bank, foreign currency liabilities and forint deposits respectively fell by Ft 0.7 billion, Ft 3 billion and Ft 0.8 billion. The average amount of NBH domestic bills held by other monetary financial institutions was Ft 5 billion lower than in March.
