Chart 1 Monthly average APRC on forint housing loans and the total amount of new business





Chart 2 Monthly average APRC on forint general purpose mortgage loans to households and the total amount of new business<sup>1</sup>

Chart 3 Monthly average APRC on forint personal loans and the total amount of new business <sup>2</sup>





Chart 4 Monthly average APRC on forint loans for purchases of goods or other consumption and the total amount of new business<sup>3,4,5</sup> 6





Chart 6 Monthly average interest rate on euro loans to non-financial corporations up to EUR 1 million and the total amount of new business

Chart 7 Monthly average interest rate on forint loans to non-financial corporations over the equivalent of EUR 1 million and the total amount of new business<sup>8</sup>





Chart 8 Monthly average interest rate on euro loans to non-financial corporations over EUR 1 million and the total amount of new business

Chart 9 Monthly average interest rate on household forint time deposits and the total amount of new business




Chart 10 Monthly average interest rate on household euro deposits with an agreed maturity of up to one year and the total amount of new business




Chart 11 Monthly average interest rates on non-financial corporations' forint deposits and the total amount of new business




Chart 12 Monthly average interest rates on non-financial corporations' euro deposits with a maturity of up to one year and the total amount of new business




Chart 13 Average overnight interbank rates, total interbank lending and the interest rate corridor
