

Monthly average and end-of-month stocks - August 2021

Summary of August 2021

The average and end-of-month stocks of **external assets** rose throughout the month. The allocation of SDR received from the IMF on 23 August and transfers from the European Commission raised the average and the end-of-month stocks. In addition, the carry-over effect of maturities of swap transactions, providing euro liquidity, made with credit institutions also contributed to the rise in average stocks. The increase was dampened by the strengthening of the forint exchange rate and a fall in the stocks of swaps providing forint liquidity.

The average stock of **collateralised long-term loans** to credit institutions was up in the month; however, there was no rise in the end-of-month stocks in August due to gradually phasing out instruments in July.

In August, the average balance of the banking system's **reserve accounts*** exceeded the required minimum reserves by a slightly smaller amount than seen in previous months (HUF 7.5 billion). Reserve requirements amounted to HUF 306.1 billion in the month.

The **average stock of currency in circulation** continued to rise throughout the month.

The increase in the average stocks of credit institutions' one-week deposits with the MNB primarily reflected a rise in the domestic **banking system's forint liquidity**.

The average stock of **central government deposits** slightly rose in August.

The average and end-of-month stock of **external liabilities** declined relative to the previous month.

At its meeting on 24 August 2021, the Monetary Council decided to raise the base rate by another 30 basis points. As a result, the base rate rose to 1.5%. The overnight central bank deposit rate and the collateralised lending rate defining the lower and upper bounds of the interest rate corridor, were also raised by 30 basis points. The average interest rate on **overnight interbank loans** (HUFONIA) stood in the bottom half of the interest rate corridor below the base rate in the month.

* Includes credit institutions' reserve accounts ('Current account balances of credit institutions – IMPS accounts') and instant reserve account balances. Instant reserve account is the part of an account managed under the Immediate Payment System (IMPS), which is counted toward the compliance with the minimum reserves by the MNB based on a special statement by credit institutions.





Components of stock change: August 2019 - August 2021 (Bn HUF)














Changes in the components of the monetary base during the selected period (Bn HUF)


Monthly average of reserve account balances of CIs - August 2021 (Bn HUF)


● Reserve surplus (right axis) — Reserve requirements of CIs — Monthly average of reserve account balances of CIs






Development in the average stock of selected central bank instruments during the selected period (Bn HUF)


Stock of external assets - August 2021 (Bn HUF)


