Preliminary statistical balance sheet of the MNB May 2003

According to the preliminary balance sheet data, the value of currency in circulation was Ft 0.7 billion higher on the last day of May than at the end of April. Annual growth in the monetary base (M0) was 114.5%.

Net claims of the central bank on the central government fell by Ft 56.7 billion. Assets and liabilities vis-à-vis the sector were Ft 9.8 billion and Ft 66.5 billion higher respectively relative to April. Net assets of the central bank vis-à-vis the rest of the world fell by Ft 104.4 billion. Total assets and liabilities were Ft 160.6 billion and Ft 56.2 billion lower respectively than in the preceding month.

Net liabilities of the central bank to other monetary financial institutions fell by Ft 202.8 billion in May. Assets were Ft 33.8 billion higher than in the preceding month, on account mainly of an increase in forint loans with agreed maturity up to one year. Other monetary financial institutions placed Ft 169 billion less domestic and foreign currency deposits with the central bank. Within liabilities to other monetary financial institutions, forint deposits fell by Ft 76.4 billion, holdings on current accounts, which include required reserves, falling by Ft 93 billion. Foreign currency liabilities, in contrast, increased by Ft 0.4 billion. Other monetary financial institutions' holdings of MNB domestic bills remained unchanged relative to April.

In May, the averages of central bank liabilities to other monetary financial institutions changed as follows: that of forint deposits fell by Ft 133.8 billion, that of current account holdings increased by Ft 1.2 billion and that of foreign currency liabilities fell by Ft 8 billion relative to April.
